The Fund's investment objective is to deliver a moderate to high long term total return with limited risk of capital loss.

# **Investment Policy**


The Fund's portfolio will invest in a combination of equities, fixed income, property and cash, in both domestic and international markets. This may also include participatory interest in other forms of local and global collective investment schemes or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager which invest in, amongst others, equity securities, property securities, non-equity securities and instruments, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interestbearing instruments and securities. A macro oriented active asset allocation process is combined with their relevant asset class's investment process, with the latter being fundamental in nature.

### **Fund Profile**

The Fund is a multi-asset medium equity invesment scheme, with a broad mandate to invest across asset classes. The portfolio maintains a moderate risk profile and the portfolio's equity exposure will be limited to a maximum of 75% of the portfolio's net asset value. The Fund may allocate up to 45% to international market exposure and will comply with the Regulation 28 limits governing retirement funds.

# Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio. 
