Investment Policy


The Fund's portfolio will invest in a combination of equities, fixed income, property and cash, in both domestic and international markets. A macro oriented active asset allocation process is combined with the relevant asset class's investment process, with the latter being fundamental in nature.

Fund Profile

In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, property securities, preference shares, convertible equities and nonequity securities. The manager may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio's investment policy. The portfolio may from time to time invest in listed and unlisted financial instruments.






